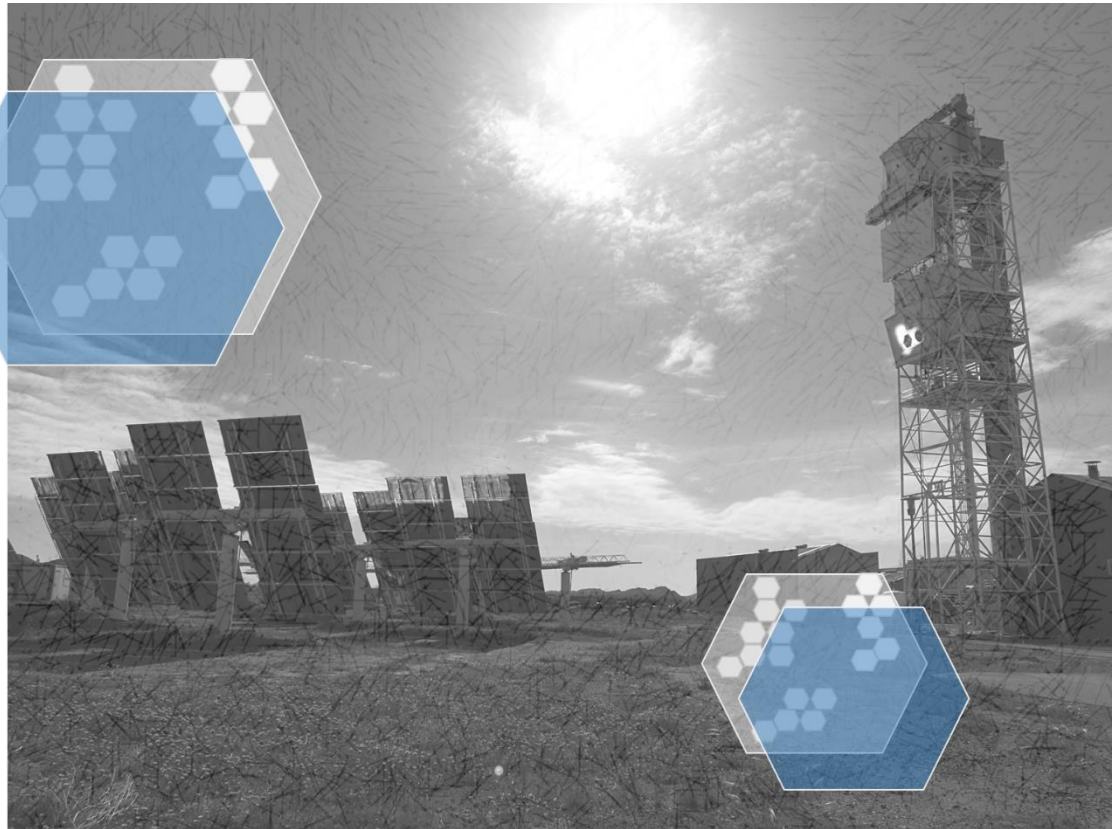

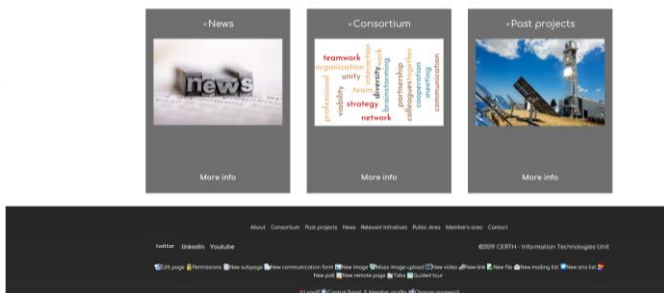
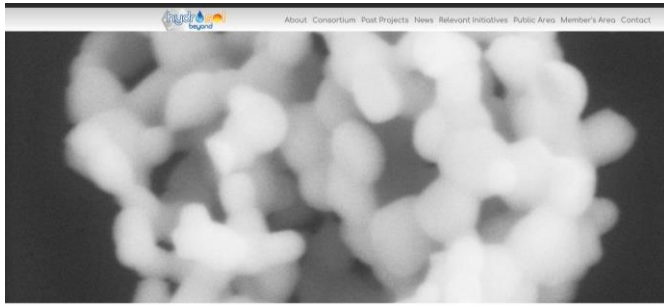

1 INTRODUCTION

This deliverable provides a short documentation for the implementation of HYDROSOL-beyond project website, officially launched in April 2019. The website was implemented and administered by APTL/CERTH, the coordinating organization of the project and it can be accessed via the following link: <http://www.hydrosol-beyond.certh.gr>.



The website has two levels of accounts:

- **Public area:** A public area that can be accessed by the general public, providing information such as the description of the project, the HYDROSOL-beyond beneficiaries, news related to any major project events and an interface via which anyone interested to the project is able to communicate with the project coordinator.
- **Member area:** A password-protected area, accessible only by the relevant project partners and the EU officer. This part contains confidential information such as links for the required reports and deliverables, the minutes and pictures taken during project meetings, several document templates, an 'electronic library' etc.

Additionally a "Search" field allows to search for a specific document or file through all the tabs depending on the account level.

1.1 PUBLIC AREA

The public area of the website is accessible by everyone and contains simple information, via which one is briefly introduced to the general concepts of HYDROSOL-beyond and to the relevant partners' main descriptions and activities. Also news links will inform the public on all dissemination activities that take place within the project.

The links available in the public section of the website are the following:

- The main page of the website with a display of the list of news related to the project.
- 'About' tab: where a short description of the project is presented
- 'Consortium' tab: with links to each partner profile
- 'Past Projects' tab: which links the current project with the previous HYDROSOL projects
- 'News' tab: with links related to project work, organization of project meetings/workshops etc.
- 'Relevant Initiatives' tab: with links to relevant to the project groupings and initiatives.
- 'Public Area' tab: for relevant material available to the general public

- 'Member's Area' tab: limited access area
- 'Contact' tab: An interface for requesting information about the project via a communication form addressed to the contact persons of the coordinating organization.

1.2 Member area

This is a password-protected area that contains confidential information about the project. All people that have been identified as 'partners' by all parties involved in the project were provided with usernames and passwords, in order to have access to this particular part of the website. Upon logging-in, the user will have access to the Member area which contains the:

- "Meetings" tab: Documents and Files related to the meetings and categorized by project meeting (e.g. Kick-off meeting, 6-month meeting etc.) that have taken place, such as the meeting agenda, the minutes and other files.
- "Reports" tab: containing all the documents referring to the periodic reports of the project and the deliverables prepared up to the current access time that can be accessed by every partner and the EU project officer.
- "Resources" tab: that consists of links related to the Description of Work, a Library which can contain in general useful material relevant to the project etc.

2 CONCLUSIONS

The project has a public area, providing non-confidential information as well as the ability to contact the project coordinator requesting further information or making comments about the project. There is also a 'member' area granting access to the partners and the FCH-JU officer to the project's confidential documents.
